To whom it may concern,

In February 2019, after Anovité product test results exceeded 3rd party laboratory testing, the Environmental Research Center ("ERC") cleared Immune Tree, Inc. and Dock of Health (DBA Anovité) from any enforcement action under California's Proposition 65 ("Prop 65") when ERC withdrew all its notices of the companies' alleged violations.

In a February 2019 letter to California's Attorney General, ERC withdrew each notice of alleged violations. (This information can be confirmed by searching under the "AG Numbers" shown above at https://oag.ca.gov/prop65/60-day-notice-search). As a result, Immune Tree, Inc. and Dock of Health (Anovité) are not subject to an enforcement action based on ERC's allegations.

Products such as herbal extracts, dairy extracts, vegetable and fruit extracts, as well as sea food extracts and mineral preparations will contain trace amounts of lead and arsenic in particular. Many corporations that do business in California, including ANOVITE, find the below legal definition of "no significant risk level" to be unjustly burdensome and difficult, if not impossible, to defend in a court of law. As such, many corporations—including ANOVITE—will now prophylactically include or attach the Proposition 65 warning with/to their products sold in California.

Lead and Arsenic occur naturally in small amounts throughout the environment. Lead and Arsenic in soil can be absorbed by plants, including plants grown for food. Lead that is introduced into a plant as it grows cannot be removed by washing or other processing. The small amounts of lead found in foods can be detected by today's highly sensitive analytical methods, but its mere presence doesn't mean it presents a risk to consumers. Ill effects occur when much larger quantities are ingested.

We test all our raw materials and finished products for heavy metals and contaminants, and we have specifications for our raw materials to ensure that they do not contain harmful amounts. Our products are formulated to meet or exceed FDA regulatory requirements governing heavy metal level limits.

CALIFORNIA PROPOSITION 65: Should anyone question Proposition 65 please refer to this document.

Proposition 65 is a California law that was voted in under the "Clean Water Drinking Bill" in the 80s. The intent was to reduce environmental pollution from contaminating our environment and to ensure clean drinking water.

This Proposition pertains to California and products available to California Consumers. In California, this warning or one similar to it is posted at VIRTUALLY ALL TYPES of businesses in California, such as: DISNEYLAND, BUILDINGS, PARKING LOTS, RESTAURANTS, COFFEE SHOPS, GROCERY STORES, FURNITURE STORES, and BEAUTY SALONS just to name a few etc.

The list of chemicals and compounds covered is extensive and exceed 900 items, many are Naturally occurring elements commonly found in foods. For example, lead and arsenic are common in sea food, dairy products, vegetables and fruits for example.






